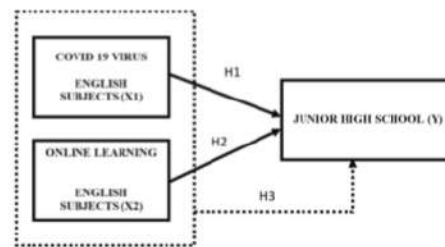


Figure 2. Hipotesis Model
